In accordance with the Federal Law of Protection of Personal Data in Possession of Individuals, InterVoice, with address in Gabino Barreda No 56 int. 315, Colonia San Rafael, Cuauhtémoc, C.P. 06470, Ciudad de México, are committed to become for the personal data of their clients and users responsible, of the use that occur to these and of their protection of way legitimate, controlled and informed in order to guarantee the privacy, as well as the right to the informative self-determination.
